**NAME**

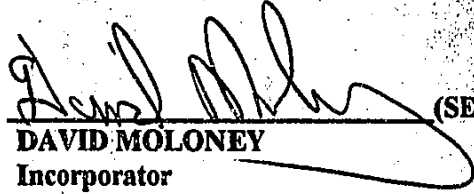

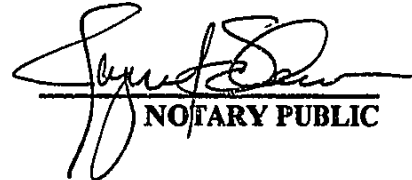
