ARTICLE I.

The name of this corporation is DE-BRAE, INC. Its principal place of business is 19420 Turkey Run Lane, Alva, Florida 33920 and its mailing address is Post Office Drawer 511447, Punta Gorda, Florida 33951-1447.

ARTICLE II.

This corporation shall have perpetual existence or shall exist until dissolved by operation of law.

ARTICLE III.
