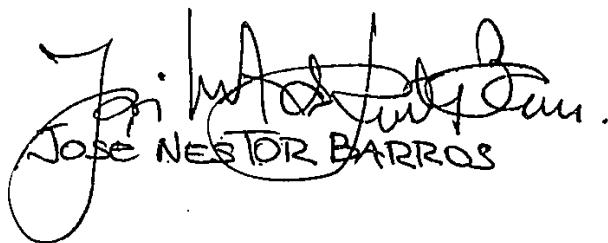

ARTICLE I - NAME

The name of this corporation is: LOCAL TRADE & EXPORT CONSULTANTS CORP.

This corporation shall have perpetual existence and may engage in any and all lawful

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the Shareholder.

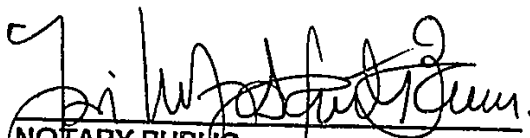
