ARTICLE I - NAME

The name and address of this corporation is: **B & P ENTERPRISES AND CONSULTANTS, INC., 648 NORTH FEDERAL HIGHWAY, FT. LAUDERDALE, FLORIDA 33304.**

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
