ARTICLES OF INCORPORATION

OF

PLATINA SNACK BAR, INC.

EFFECTIVE DATE
7-15-97

I, the undersigned natural person of the age of twenty-one years or more, acting as incorporator of a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation is PLATINA SNACK BAR, INC.

ARTICLE II. GOVERNING LAW

This corporation is organized pursuant to the provisions of the Florida Business Corporation Act.

ARTICLE III. DURATION

The period of its duration is perpetual, commencing on the date of July 15, 1997.

ARTICLE IV. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V. CAPITAL STOCK

This corporation is authorized to issue one thousand (1,000) shares of one cent (\$.01) par value stock.

ARTICLE VI. INITIAL REGISTERED AGENT AND OFFICE


