ARTICLES OF INCORPORATION
OF
EASTER BUSINESS SOLUTIONS, INC.

ARTICLE I

The name of this corporation is: EASTER BUSINESS SOLUTIONS, INC.

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.


