ARTICLES OF INCORPORATION

1480 EAST RADIO, INC.

ARTICLE I - NAME

The name of this corporation is 1480 EAST RADIO, INC

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business in which corporations may be incorporated under the Florida General Corporations Act.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common stock.

ARTICLE V - ADDRESS OF PRINCIPLE OFFICE

ARTICLE X - BY-LAWS

ARTICLE XI - SHAREHOLDERS MEETINGS

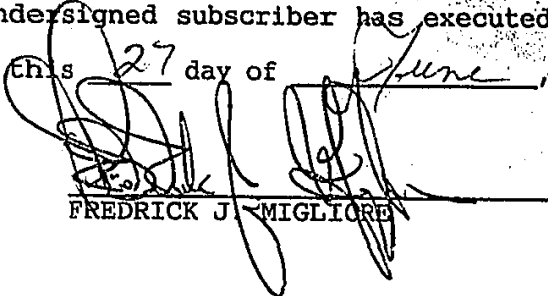

quorum for such meeting shall consist of a majority of those eligible to vote, and a majority of those actually voting shall be sufficient to take any action.

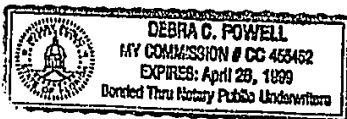

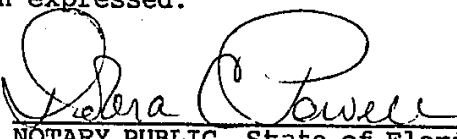

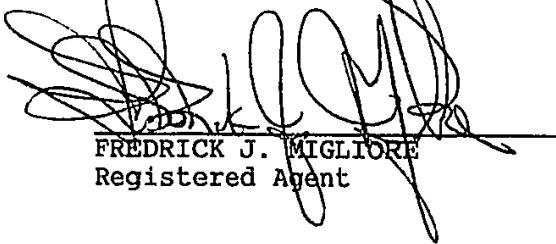
