# ARTICLES OF INCORPORATION OF CENTER FOR NICOTINE ADDICTION, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

EFFERYIVE DATE

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is CENTER FOR NICOTINE ADDICTION, INC. and its principal office and mailing address is 3725 W. Grace Street, Suite 300, Tampa, FL 33607.

# ARTICLE II

# Commencement of Corporate Existence

The corporation shall come into existence on July 10, 1997.

## **ARTICLE III**

#### General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

## **ARTICLE IV**

#### Capital Stock

The aggregate number of shares of capital stock authorized to be issued by the Corporation shall be 5,000 shares of Class A common stock, each with a par value of \$1.00 (the "Class A Stock"), and 5,000 shares of Class B common stock, each with a par value of \$1.00 (the "Class B Stock").
