CENTER FOR NICOTINE ADDICTION, INC., a Florida corporation (the
"Corporation"), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

"ARTICLE I
Corporate Name and Principal Office

The name of this corporation is HolCam Enterprises, Inc. (the "Corporation") and its principal office and mailing address is 3725 West Grace Street, Suite 300, Tampa, Florida 33607."

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.

3. The amendment recited in Section 1. above has been adopted in accordance with the provisions of §607.1005, Florida Statutes, the Corporation's sole incorporator having executed a written statement, dated December 8, 1997 manifesting her intention that the amendment be adopted; and at the time of such execution there being no need for shareholder or other action inasmuch as no shares of the Corporation's authorized capital stock had then been issued nor an initial board of directors selected.
