ARTICLES OF INCORPORATION
OF

LARRY S. MORRISON, INC.

ARTICLE I - NAME

The name of the corporation is "LARRY S. MORRISON, INC." (hereinafter called the "Corporation").

ARTICLE II - ADDRESS OF PRINCIPAL OFFICE AND MAILING ADDRESS

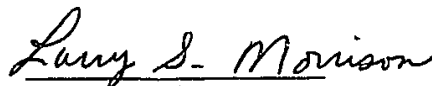
ARTICLE VII - COMMENCEMENT
