ARTICLES OF INCORPORATION
OF
WEST FLORIDA CLAIM SERVICES, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is **WEST FLORIDA CLAIM SERVICES, INC.** The address of the principal office of this corporation shall be 603 133RD St. E., Bradenton, Fl 34202, and the mailing address shall be the same.

ARTICLE II. NATURE OF BUSINESS

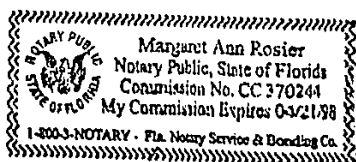

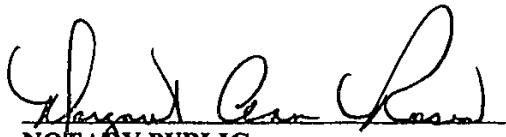
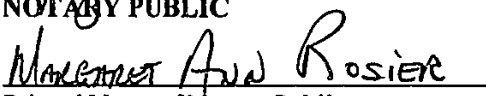
