ARTICLES OF INCORPORATION OF KEN'S COMPUTERS, INC.

SECRETARY OF STATE DIVISION OF CORPORATIONS 97 JUL 16 AMII: 45

ARTICLE I - NAME

The name of this corporation is Ken's Computers, Inc. with a principal office and mailing address of 2452 NE 3rd Street, Ocala, FL 34470.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of this Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607. Florida Statutes, as now exists or may after be amended.

ARTICLE IV - AUTHORITY OF DIRECTORS
