**ARTICLES OF INCORPORATION
OF

The undersigned subscribers to these Articles of Incorporation each a natural person competent to contract hereby associate themselves to form a corporation under the laws of the State of Florida.

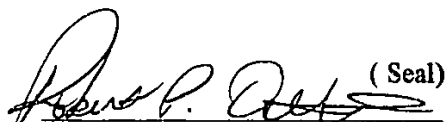
ARTICLE X

ARTICLE XI

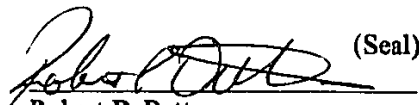

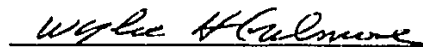
