ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
SBA CONSTRUCTION ACQUISITION, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, SBA CONSTRUCTION ACQUISITION, INC., a Florida corporation (the "Corporation"), hereby amends its Articles of Incorporation as follows:

Article I and Article IV of the Corporation's Articles of Incorporation are amended in their entirety to read as follows:

The name of this Corporation is Communication Site Services, Inc.


Article IV
