The undersigned incorporators, for the purpose of forming a Professional Association under Florida's Professional Service Corporation Act, hereby adopt the following Articles of incorporation.

ARTICLE 1: Name

The name of the Professional Association shall be SANFORD M. MARTIN, P.A.

ARTICLE 2: Principal Place of Business

The principal place of business of this Professional Association shall be 2500 Airport Road, Suite 315, Naples, Florida 34112.

ARTICLE 3: Shares

All stock issued by this Professional Association shall be common voting stock of a single class. The number of shares that this Professional Association is authorized to have outstanding at any time is: 100.

ARTICLE 4: Initial Registered Agent and Registered Office

The name of the initial registered agent is Sanford M. Martin, whose registered office is located at the place of business stated in Article 2 above.


ARTICLE 5: Purpose and Restrictions

Should any such person lose the license to so practice, that person shall immediately sever all employment with, and financial interests in, this Professional Association.


