

**ARTICLES OF INCORPORATION
OF
Overdors of Tallahassee, Inc.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

Article I - Name

The name of the corporation is Overdors of Tallahassee, Inc..

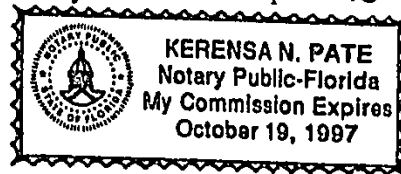
