During the course of doing my 1998 Income Tax Return, my CPA became aware that my corporation, Suncoast Sport Aircraft, Inc. had been dissolved because there was no Annual Report filed in 1998.

Since my former Registered Agent, Mark Gruwell, Esq., 747 N. Washington Blvd., Sarasota, Florida, used to take care of these matters, he did not notify that the Annual Report for 1998 needed to be filed. Since I also moved from the address under which the corporation was initially filed, I did not receive the notice.
