Subject: Reinstatement of JSM Corp of Boca Grande


Last week when a new lessor was doing a credit check on our corporation he advised us that our corporation had been dissolved in late 1998 for non filing of our Annual Return and non payment of related fees.

Obviously we were astounded since we have been carrying on business continuously since inception and have filed all government forms we were aware of including our monthly Florida Sales Tax forms and our annual Florida Tangible Tax returns.

Upon further investigation with our attorneys we found out that the Annual Return Forms had apparently been mailed to our physical address in Boca Grande without inclusion of our P. O. Box # - and therefore were returned to the sender. Boca Grande does not have delivered mail service but up until about two years ago the Post Office used to put mail in the correct P. O. Box even if the Box # was not on the letter.

Since we never received the last two Annual Returns which were mailed to us we would appreciate your waiving the penalty and reinstating our corporate entity for payment of the required filing fees.
