This corporation shall have no more than 1000 shares of common stock outstanding at any time.

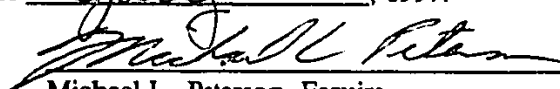

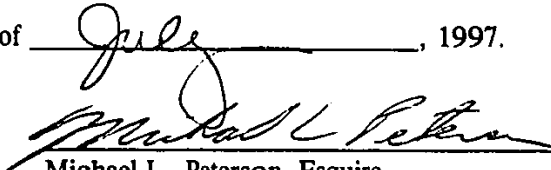
