ARTICLE I - NAME & ADDRESS

Gayla Sue Levin, both of 100 Bay Colony, Ft. Lauderdale, FL 33308.

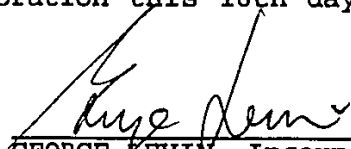
ARTICLE VII - INCORPORATOR
