

ARTICLES OF INCORPORATION

I, David M. Trotter, the undersigned, as a proper person acting as incorporator of a corporation under the laws of the State of Florida, adopt the following Articles of Incorporation:

FIRST

The name of the corporation is: **Hartford Administrative Services, Inc.**

SECOND

The period of duration is: **In Perpetuity.**

THIRD


