

ARTICLES OF INCORPORATION OF CARIBBEAN OCEAN HOTEL CORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby organizes and incorporates a corporation under the laws of the State of Florida.

ARTICLEL NAME

The name of the corporation is CARIBBEAN OCEAN HOTEL CORPORATION
