ARTICLES OF AMENDMENT

(Corporate Name Change)

ARTICLE I.

The name of the corporation is QUIXOTIC COACHES CORPORATION, a corporation organized under the laws of the State of Florida, filed on July 18, 1997 under document number P97000062484.
