ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is FLORIDA CONVENTION CENTER, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE
