SECOND: The new name of the corporation is TEDDER, JAMES, WORDEN & ASSOCIATES, P.A.

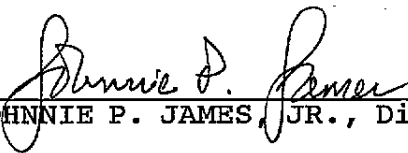
THIRD: Article VII - Initial Directors is amended to add the following as a director:
