The undersigned incorporator, being a natural person competent to contract, subscribes to these Articles of Incorporation to form a corporation under the laws of the State of Florida.

I. NAME

The name of this corporation is J. R. and Associates Investments, Inc. and its principle place of business is 2344 Enfield Court, Orlando, Florida 32837.

II. PURPOSE

The purpose for which the corporation is organized to operate and manage a restaurant and perform any other lawful purpose.

III. DURATION
