ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

JAVALIX INTERNATIONAL CORPORATION

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its article of incorporation:

FIRST: Amendments adopted:

(a) The First Article is hereby amended to change the name of the corporation and shall read:

FIRST

The name of the corporation shall be Worldforyou.com Incorporated

(b) The Fourth Article is hereby amended to increase the number of authorized shares the company is authorized to have outstanding at any one time, and shall read:
