The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

**I.
Name**

The name of the Corporation is Karen Palacios Golf Enterprises, Inc.

**II.
Term of Existence**

The date when corporate existence will commence is July 21, 1997 in accordance with the provisions of Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

**III.
Principal Office**

**IV.
Capital Stock**

The Corporation is authorized to issue 100 shares of \$.10 par value common stock, which will be designated Common Stock.

Therefore, the terms and provisions of Section 607.0902 will not apply with respect to any control-share acquisition of any equity securities of the Corporation and the equity securities of the Corporation will have any and all other rights and privileges available under the Act.
