Articles of Incorporation

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

Article 1 -- Name

The name of the corporation is CENTRAL FLORIDA WEB DESIGN, INC.
("Corporation")

Article 2 -- Principal Office/Mailing Address

The street address of the initial principle office is 5501 Silent Brook Drive,
Orlando, Florida 32811.

Article 3 -- Shares

The number of shares the corporation is authorized to issue is 100 shares.

Article 4 -- Initial Registered Office and Agent


Article 11 -- Amendment
