ARTICLE I- NAME

STATE
TALLAHASSEE, FLORIDA

The name of this Corporation is North American Legal Software, Inc..

ARTICLE II- NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE III- TERM OF EXISTENCE

The Corporation is to exist perpetually.

ARTICLE IV- AUTHORIZED SHARES


