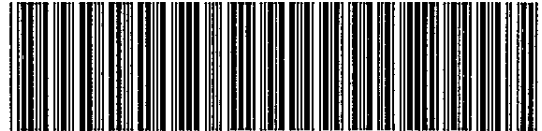

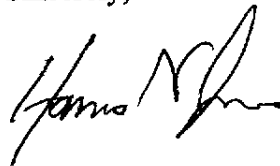

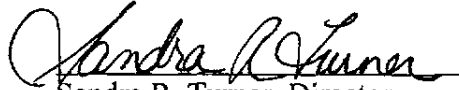
ARTICLE II
