# ARTICLES OF INCORPORATION

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

# **ARTICLE ONE**

The name of the corporation is: NATURE'S GARDEN, INC.
