Pursuant to Section 607.1002 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of D P MEDIA OF ST. LOUIS, INC. (the "Corporation"), are hereby amended according to these Articles of Amendment:

**FIRST:** The name of the Corporation is D P MEDIA OF ST. LOUIS, INC.

**SECOND:** Article 1 of the Articles of Incorporation is amended in its entirety to read as follows:

"The name of the Corporation is PAXSON COMMUNICATIONS OF ST. LOUIS-13, INC."

**THIRD:** The foregoing amendment was adopted by written consent of the sole shareholder of the Corporation, in accordance with Section 607.1003(6) and 607.0704 of the Florida Statutes, on April 23, 2002 constituting a sufficient number of votes to approve the amendment.
