

ARTICLES OF INCORPORATION

OF

We, the undersigned subscribers to the Articles of Incorporation of Bama Publishing, Inc., each being a natural person competent to contract, hereby associate ourselves together for the purpose of forming a corporation under the Laws of the State of Florida.

## ARTICLE VIII - STOCKHOLDERS






