ARTICLE I - NAME

The name of this Corporation is SERVITUR, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing

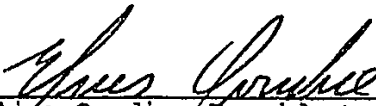

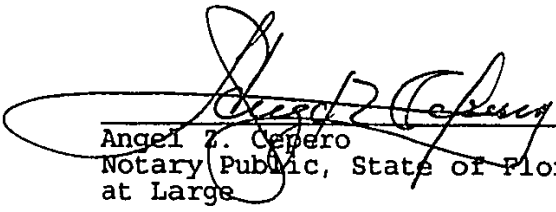

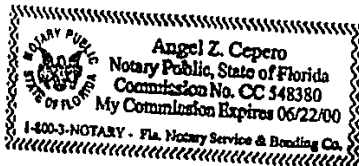
