## Articles of Incorporation of RiXSoft Corporation

The undersigned person, acting as incorporator for the purpose of forming a stock business corporation under the laws of the State of Florida, adopts the following article of incorporation:

- Article I.** The name of corporation shall be RiXSoft Corporation.
