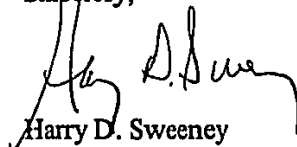

## ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

### ARTICLE I

Name: The name of the corporation is HARRY D. SWEENEY CPA, P.A.

### ARTICLE II

Nature of Business: The general purposes for which the corporation is organized are:

To render the following specific professional services (as defined in Section 621.03 of the Professional Service Corporation Act) and none other, to wit: the personal services rendered by public accountants as provided by Chapter 473 of the Florida Statutes or any successor statute provided therefor.

And in connection therewith and in the furtherance thereof, possess and exercise all the powers and privileges granted by these Articles of Incorporation together with any powers incidental thereto, so far as such powers and privileges are consistent with, and not prohibited by, the Professional Service Corporation Act.

### ARTICLE III

Capital Stock: The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock with a par value of \$1.00 for each share.

### ARTICLE IV

Term of Existence: This corporation is to exist perpetually unless sooner dissolved according to law.

### ARTICLE V

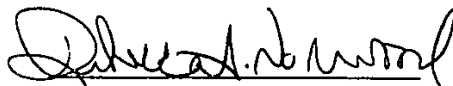

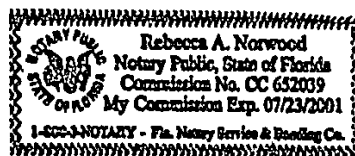

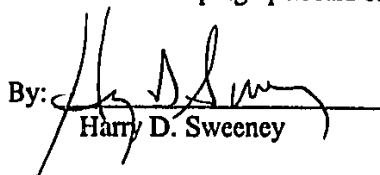
