ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE TALLAHASSEE, FLORIDA

RIDGEBACK ENTERPRISES, INC.

I. NAME

The name of the corporation is RIDGEBACK ENTERPRISES, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.
