

ARTICLES OF INCORPORATION

OF

MIDBAY BUILDER'S GROUP, INC.



ARTICLE I

NAME

The name of this corporation shall be MIDBAY BUILDER'S GROUP, INC., hereinafter referred to as the corporation.

ARTICLE II

DURATION

The corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Florida Department of State.
