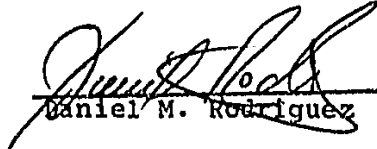
#### ARTICLE XI

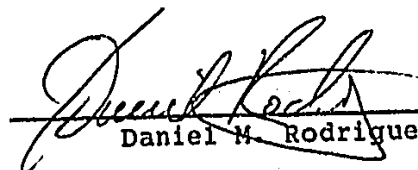
