ARTICLES OF INCORPORATION
OF

ARTICLE I.
CORPORATE NAME

The name of this corporation is:

Sebastian's Restaurant, Inc.

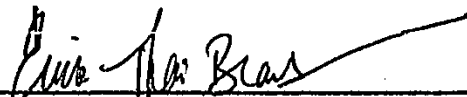

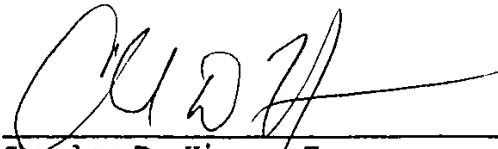

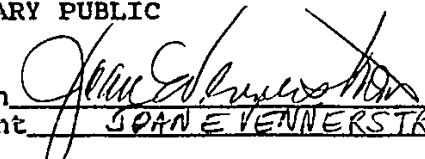
