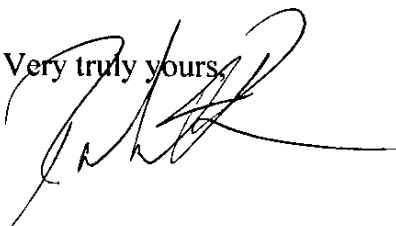

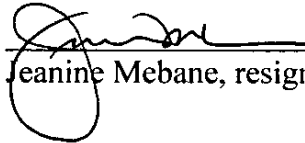
OFFICER RESIGNATION FOR A FLORIDA CORPORATION
