The undersigned, desiring to form a Corporation under the Laws of the State of Florida, hereby certifies as follows:

FIRST: The name of the Corporation shall be: **PILOT PERCEPTIONS, INC.**

SECOND: The Corporation shall commence existence upon having its Articles of Incorporation filed by the State of Florida.



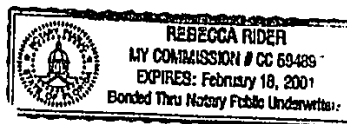


