The name of this corporation shall be **CHRIS MATINCHECK PLUMBING, INC.**

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

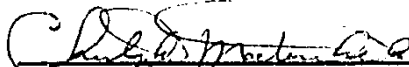

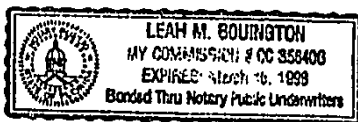
