Pursuant to the provisions of Section 607.181 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendments of its Articles of Incorporation:

1. The name of the corporation is Location Resources, Inc.
2. The following amendments of the Articles of Incorporation were adopted by the shareholders (or board of directors if no shares have been issued) of the corporation on July 31, 1997, in the manner prescribed by the Florida General Corporation Act:

The articles of incorporation shall be amended changing the name of the corporation from Location Resources, Inc. to Labrooksberg, Inc.

3. The number of shares of the corporation outstanding at the time of adoption was 100, and the number of shares entitled to vote thereon was 10.
