Name

The name of the corporation and its principle business address:

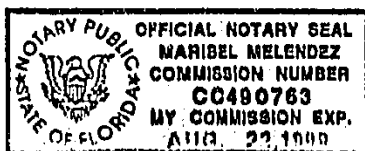
