#### ARTICLES OF INCORPORATION

OF

# HARPER-JENKINS CONSTRUCTION, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I - Name

The name of the corporation is HARPER-JENKINS CONSTRUCTION, INC.

# ARTICLE II - Principal Office and Mailing Address of the Corporation

The address of the principal office of the corporation is 3240 Galloway Road, Lakeland, Florida 33810 and its mailing address is the same.

# ARTICLE III - Commencement and Duration

The corporation is to commence its corporate existence effective upon filing, and shall exist perpetually thereafter until dissolved according to law.

### ARTICLE IV - Purpose

The corporation is organized for the purpose of transacting any and all lawful business.

#### ARTICLE V - Stock

The corporation is authorized to issue ten thousand (10,000) shares of \$0.25 par value common stock, which shares shall be a single class.

#### ARTICLE VI - Preemptive Rights

#### ARTICLE VII - Board of Directors

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the board of directors.

The corporation shall have one director initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation.
