ARTICLES OF INCORPORATION

ARTICLE I. NAME AND ADDRESS

The name of this corporation is Decorative Designers, Inc., and the address of the corporation shall be 90 S. Highland Avenue, Tarpon Springs, Florida 34689.

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

The date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

ARTICLE III. DURATION

This corporation shall exist perpetually, commencing on the date of the subscription and acknowledgment of the Articles of Incorporation.

ARTICLE IV. PURPOSE
