The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation

**ARTICLE I
NAME**

The name of the corporation shall be :

**ARTICLE II
PURPOSE**

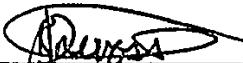

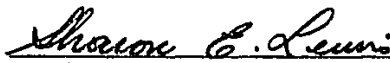
