The undersigned, acting under the Florida General Corporation Act, TALLAHASSEE, FLORIDA
adopt the following Articles of Incorporation:

ARTICLE 1 : NAME

The name of this corporation is :

Clemons Insurance Agency, Inc.

ARTICLE 2 : DURATION

It's duration is perpetual.

ARTICLE 3 : PURPOSE

The purpose is to engage in any activities of business permitted under the laws of the United States and the State of Florida.

As provided by law, members of the Board of Directors may participate in special, regular, and annual meetings of the Board of Directors by means of conference telephone or similar communications equipment.

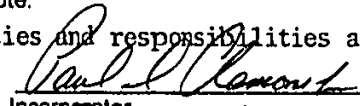
ARTICLE 11 : INDEMNIFICATION
